AFFIDAVIT

This AFFIDAVIT is sworn to by me, Neil Francis Keenan, on this 18th day of May 2023 with respect to serious death threats to the former President of The United States of America and current Presidential Candidate, Donald J. Trump, as well as, death threats against myself, the principal AMANAH of the Republic of Indonesia (the Financial TRUSTEE) having the Diplomatic Rank equivalent to the President of that country, in statements made verbally and in writing severally and jointly by Mr. James Dugan and Jeanne O'Dean, both residents of Tampa, Florida starting in mid-April 2023 and repeated numerous times till today arising from a failed scam attempt perpetrated by both Parties against me personally.

I personally received a phone call from Mr. Dugan in mid-April in which he embarked in a highly slanderous and defamatory yelling tirade against President Trump, clearly stating that he was a former US Army sniper, still carried a US Military passport and that "I would like to put a bullet in Trump's head!"

I believe that anyone with James Dugan's hatred and military credentials that makes a clear statement or threat to assassinate a US President or Presidential candidate should be arrested and thoroughly investigated as this is a most serious offence especially since he lives in Florida.

Secondly, the threat to assassinate Indonesia's AMANAH and persons associated with him, constitutes a major international diplomatic illegality equivalent to threatening to murder a foreign Head of State. This should result in the immediate issuance of international arrest warrants by all international intelligence agencies and Interpol authorities.

According to their recent Facebook posts, Mr. Dugan is currently in Dubai working up a Ugandan gold scam while Jeanne O'Dean is soliciting investors in the US for him in what appears to be another Ponzi scheme.
